Harris County Public Library Gardening Tools Policy

Borrowing

- Anyone with a Harris County Public Library card in good standing can borrow tools from the Baldwin Boettcher Branch Library.
- You may borrow a total of 40 (Up to 20 small tools and up to 20 large tools).

Loan Period

• Lending period for tools is 14 days with no renewals. You may return the item and borrow it again if there is not a waiting list for the tool.

Fines and Fees

- Late Fees:
 - Small tools- \$.10 per day/ \$3 maximum
 - Large tools- \$2 per day/ \$100 maximum
 - After the tool has been late by 120 days, a replacement fee will be charged. Speak to a staff member if you are interested in replacing the tool rather than paying the replacement fee.
- Tool replacement fees will be charged for any lost items. If the lost material is recovered you may request a refund within one year of payment date.
- If the item is returned damaged, you will be charged the tool replacement fee.

Holds

Contact any HCPL branch to place a hold. Tools are only available for pick up at Baldwin Boettcher Branch Library.

Returns

- Tools must be returned to Baldwin Boettcher Branch Library during open hours. Failure to return to this location will result in loss of tool borrowing privileges.
- If the item is returned damaged, you will be charged the tool replacement fee.
- Please clean tools before returning them. Failure to do so may result in loss of tool borrowing privileges.

Harris County Public Library retains the right to refuse the loan of any item for failure to comply with any of the above rules and regulations, or for falsification of any information.
